Notice - Overbooking of Flights

With few exceptions, including failure to comply with the carrie'rs check-in deadline of 60 minutes prior to each flight segment, persons denied boarding involuntarily are entitled to compensation. The complete rules for the payment of compensation and each airline's boarding priorities are available at all airport ticket counters and boarding locations. However, some airlines do not apply these consumer protections to travel from some foreign countries, although
